TRAINING PROVIDERS' CIRCULAR NO. 1/2021

ENHANCEMENT OF THE TERMS AND CONDITIONS FOR ONLINE TRAINING

1.0 PURPOSE

The purpose of the circular is to inform Human Resources Development Fund (HRDF) registered training providers on the enhancement of terms and conditions for Online Training.

2.0 BACKGROUND

- 2.1 In 2020 HRDF has allowed remote online training (ROT) to be covered under HRDF financial assistance in order to support training landscape during COVID-19 pandemic.
- 2.2 In addition to the remote online training, HRDF has also enhanced terms and conditions of the online training to facilitate the training needs of the registered employers.
- 2.3 Based on the industry feedback, the HRDF Board has approved enhancement to the terms and conditions of the online training to assist the Malaysian employers to continue improving the knowledge and skills of their workforce.



3.0 REVISED GUIDELINE: ONLINE TRAINING GUIDELINE

3.1 Terms and Conditions

The enhancement to the terms and conditions for online training grant applications under HRDF are as follows:-
