EMPLOYERS CIRCULAR NO 3/2017

IMPLEMENTATION OF RURAL ACCELERATED INDUSTRY SKILL FOR **EMPLOYMENT (RAISE) PROGRAMME**

1.0 **PURPOSE**

1.1 The purpose of this circular is to inform registered employers on the implementation of the Rural Accelerated Industry Skill for Employment (RAISE) programme.

2.0 **BACKGROUND**

- 2.1 The Pembangunan Sumber Manusia Berhad (PSMB) Human Capital Strategic Initiatives were devised in line with the Eleventh Malaysia Plan (RMK-11) to achieve the national agenda in order to attain a 35 per cent of Malaysian skilled workforce by year 2020.
- 2.2 As part of PSMB's Human Capital Strategic Initiatives to support the nation's Human Capital agenda, PSMB is implementing a programme called RAISE. This initiative is to increase the supply of skilled local workforce to PSMB registered employers or industries covered under Pembangunan Sumber Manusia Berhad Act 2001 (PSMB Act 2001) by providing the platform to reduce the rate of unemployment of rural youths, thus contributing to the increase of income in rural households, especially those who are within the Bottom 40 (B40) category.

2.3 RAISE is one of the sub-programmes under the Future Workers' Training that focuses on intensive training for rural youths to meet the needs of the PSMB registered employer or industries covered under the PSMB Act 2001 to guarantee employment after the completion of training.

3.0 OBJECTIVES

- 3.1 The objectives of the RAISE programme are:
 - To provide access for rural youths to undergo specific skills training based on the operational requirements of the employer before being absorbed into the job market upon completion of training;
 - ii. To increase the supply of skilled workforce through strategic partnerships with PSMB registered employers and employers covered under the PSMB Act 2001 in order to support manpower requirements of Regional Economic Corridors; and
 - iii. To reduce unemployment rate, especially among rural youths that will eventually support Government's aspiration in achieving 35 per cent of skilled workforce by year 2020.

4.0 TRAINING & FINANCIAL ASSISTANCE

- 4.1 Employers' associations / PSMB registered employers or industries covered under PSMB Act 2001 may request for financial assistance to train rural youths to meet the needs of organisation manpower.
- 4.2 Courses offered under this programme will provide opportunities for rural youths to access skill- training and subsequently

secure employment with the PSMB registered employers or industries covered under PSMB Act 2001 **upon completion of their training.**

- 4.3 The training will be offered either by the employer associations, appointed training providers or internal trainers of the employers. Employers Associations and employers must ensure appointed providers will arrange for job placements upon the completion of the training.
- 4.4 Under this programme, PSMB registered employers or industries covered under PSMB Act 2001 are eligible to claim the allowable training cost as follows:
 - i. Course Fee (Training conducted by appointed training provider); or
 - ii. Internal Trainer Allowance (Training conducted by internal trainer);
 - iii. Trainees' Monthly Allowance;
 - iv. Transportation Cost; and
 - v. Consumables Training Materials.
- 4.5 RAISE program is a strategic collaboration with employers through cost-sharing concept to meet the needs of skilled workforce by employer, thus employer is responsible to pay the cost for trainee's accommodation during the training. Employers are also responsible to provide group insurance to trainees during the training period.
- 4.6 Interested employer associations/employers may refer to the implementation guideline and the proposal format to apply for training grant under this programme.

5.0 DATE OF IMPLEMENTATION

5.1 The effective implementation date of this circular is May 2017.
