## **EMPLOYER'S CIRCULAR NO. 04/2016**

### **NEW ESLIP FOR PAYMENT TO PEMBANGUNAN SUMBER MANUSIA BERHAD**

#### **1.0 PURPOSE**

- 1.1 The purpose of this circular is to inform employers and training providers the implementation of the new ESLIP to make payment to Pembangunan Sumber Manusia Berhad (PSMB) such as payment of levies, arrears , interest, payment for training providers registration and renewal and others.

#### **2.0 BACKGROUND**

- 2.1 Since September 2014, PSMB had implemented ESLIP with the launching of the new system (e-Tris). ESLIP is used to make payment to PSMB and can be printed from the system through online application. Payment such as levies, arrears, interest, training provider's registration and renewal fees use the ESLIP to make payment.

#### **3.0 IMPLEMENTATION**

- 3.1 To improve service delivery and effective collections of payments, PSMB will be introducing new ESLIP for all payments made to PSMB effective from **17<sup>th</sup> September 2016**.

3.2 Besides new format, this new ESLIP will generate only numeric transaction ID instead of current alphanumeric transaction ID. Below is the example of transaction ID;

Old transaction ID : 004TL6

New transaction ID : 09064567121

3.3 Starting from 17<sup>th</sup> September 2016, employers and training providers can print the new ESLIP to make payments and the current ESLIP with alphanumeric transaction ID will be void and cannot be used to make payment at banks. Implementation of the new ESLIP is schedule as below:-

Date	Actions
15 <sup>th</sup> September	Last day for current ESLIP can be printed out by employers and training providers
15 <sup>th</sup> September	Last day to make payment at the bank counters using the current ESLIP
16 <sup>th</sup> September	Current ESLIP application will be disabled.
16 <sup>th</sup> September	Bank start to reject the old ESLIP at counters.
17 <sup>th</sup> September	New ESLIP launch and banks only accept new ESLIP for payments at counters.

3.4 For online payment through HRDF portal, employers and training providers are advised to perform payment and approve the payment at bank portal at least before 16<sup>th</sup> September 2016.

3.5 Current ESLIP with alphanumeric transaction ID can only be used on or before 15<sup>th</sup> September 2016 (bank operations hours' end at 4.00pm). The bank will reject ESLIP with alphanumeric beginning 16<sup>th</sup> September 2016 and a new ESLIP needed to be printed by employers or training providers on 17<sup>th</sup> September 2016 to perform the payment.

## **4.0 CLOSING**

- 4.1 Employers and training providers are advised to follow the cut-off date scheduled above to avoid any inconvenience or late charges imposed during the implementation of the new ESLIP.
