TRAINING PROVIDERS' CIRCULAR NO. 7/2020

ENHANCEMENT OF THE TERMS AND CONDITIONS FOR REMOTE ONLINE TRAINING

1.0 PURPOSE

The purpose of the circular is to inform Human Resources Development Fund (HRDF) registered training providers on the enhancement of terms and conditions for remote online training in order to encourage registered employers to continue to conduct training for their employees.

2.0 BACKGROUND

- 2.1 The impact of COVID-19 pandemic has changed the training landscape and on 15 May 2020, HRDF had allowed remote online training to be covered under HRDF financial assistance.
- 2.2 Subsequently on 01 July 2020, HRDF revised the terms and conditions of remote online training in response to the feedback received from the stakeholders.
- 2.3 As part of our continuous improvement, based on the industry feedback, HRDF has further revised the terms and conditions to assist the Malaysian employers to retrain and reskill their employees.

3.0 REVISED GUIDELINE

3.1 The new Terms and Conditions

 The revised terms and conditions will be applicable to the new grant applications submitted with training commencement dates after the effective date of this circular.
