4 Mode of payment

(1) Payment of the compound must be made in cash or by money order, postal order, cashier's order, banker's order or banker's draft made payable to the Officer in Charge and crossed "Account Payee Only".

(2) An official receipt for such payment shall be issued to the person to whom the offer to compound was made.
